

This, in addition to the fact that the current machining contest is not represented at the National SkillsUSA Conference, are our primary reasons for requesting this addition.

I believe that TMCC is willing to hold the contest at their campus and I'm sure a contest chair can be found with their assistance as well. Please let us know how we can assist in making the CNC Turning Specialist a reality for this year's conference or if you have additional questions.

Dear Ms. Read:

This is a follow-up to the voice-mail message I left you about the possibility of Nevada offering a state-level SkillsUSA Criminal Justice Quiz Bowl at its State Leadership and Skills Conference in 2017.

Over the past several years, we have had a state-only contest in Georgia called the Criminal Justice Quiz Bowl. The rules for that contest can be found

here: http://www.skillsusageorgia.org/contestguidelines/CriminalJusticeQuizBowl.pdf. As stated in the rules, the purpose of the Criminal Justice Quiz Bowl is "[t]o test the knowledge of selected team members on their academic knowledge in the areas of criminal law and criminal procedure; their familiarity with current events in criminal justice; and their knowledge of the SkillsUSA Leadership Handbook." As the Business & Industry representative for the legal profession, we wrote the rules of the competition; we write the questions for each year's quiz bowl; and, on the day of competition, we check in the teams and run the contest. The response from students and teachers has been very positive; in fact, the number of teams registered last year required us to schedule two preliminary rounds before the final round.

As you know, the Georgia gold-medal-winning team cannot progress to the national level because the Criminal Justice Quiz Bowl does not currently exist as a national SkillsUSA contest. We would like to change this and are therefore working on an Application for Demonstration Contest Status. One of the requirements of that application, which we would like to submit in early 2017 for consideration at the August 2017 State Association Directors meeting, is that at least 10 states be committed to conducting the contest at the state level. Accordingly, we are reaching out to invite Nevada to join with us in sponsoring the Criminal Justice Quiz Bowl at the state level during the 2016-2017 school year.

We recognize that most state SkillsUSA programs are stretched to their limit already, so we want to make it as easy as possible for other states to sponsor the Criminal Justice Quiz Bowl. To that end, we contemplate that other states will use our rules and our questions. We draw all of our academic knowledge questions from a single textbook used by high school public safety programs nationwide, and we write new current events questions each year from the sources specified in our rules. To give you a sense of the types of questions we ask, I have attached last year's PowerPoint (we display the questions, in addition to reading them, because some students do not process oral information as quickly as others). We use a proprietary font in our PowerPoints, so don't be surprised if the formatting looks funny. We do ask that you keep this PowerPoint presentation confidential, as the answers to the questions are contained in the notes field on each slide, and we do not want the questions and answers getting out to students. Thus, we anticipate that the only work required of your staff will be to provide sufficient staff members or volunteers to actually run the Criminal Justice Quiz Bowl on the day of the state competition. We generally provide two State Bar of Georgia staff members and a non-attorney volunteer to check in the teams, keep score, and read the questions; the buzzer apparatus is provided by SkillsUSA Georgia, and a SkillsUSA Georgia advisor operates that


apparatus. In some years, we have used high school and law school student volunteers as scorekeepers and check-in staff.

We would be delighted to have SkillsUSA Nevada join us in offering a Criminal Justice Quiz Bowl during the upcoming school year. Please let us know if you have any additional questions about the operation of the SkillsUSA Georgia Criminal Justice Quiz Bowl or the resources we are prepared to provide. We look forward to receiving your response at your earliest convenience. Thanks for your consideration, and we hope to be working with you soon!
