We, the undersigned being natural persons of the age of twenty-one or more and citizens of the United States, for the purpose of forming a nonprofit corporation under Chapter 82 of the laws of the State of Nevada, do hereby adopt the following Articles of Incorporation.

ARTICLE F Name

The name of this corporation is the "Nevada Association of the Vocational Industrial Clubs of America."

ARTICLE II Period of Duration

The period of duration of the corporation is perpetual.

ARTICLE III Resident Office and Resident Agent

The address of its initial resident office in the State of Nevada, is the Department of Education, 700 East Fifth Street in the city of Carson City, and the name of its initial resident agent is Michael J. Raponi whose address is the Department of Education, 700 East Fifth Street in the city of Carson City.

ARTICLE IV Purposes

The corporation shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any further Revenue Law), and shall in furtherance thereof, without regard to sex, race, creed or national origin, develop leadership abilities and interest in vocational education for students who are residents of Nevada and enrolled in a coherent sequence of courses with vocational and industrial objectives, by providing guidance and assistance to local student chapters dedicated to the development of such abilities and interest through participation of vocational or other educational activities; provided however, that no part of the net earnings of the corporation shall inure to the benefit of any private member or individual, and provided further that no substantial part of its activities shall involve the carrying on of propaganda, or otherwise attempt to influence legislation.

ARTICLE V Powers

The corporation shall have the power to do all lawful acts necessary or desirable to carry out its purposes consistent with the provisions of the (applicable state not-for-profit corporation act) and Section 501(c)(3) of the Internal Revenue Code.

ARTICLE VI Nonprofit

This corporation is organized on a nonprofit, non-stock basis.

The adult members of this corporation shall consist of the adult chapter advisors within the State of Nevada, who are professional members in good standing of the Vocational Industrial Clubs of America, Inc. Voting rights of the adult members shall be in accordance with the Bylaws of this corporation. Only members in good standing of this association and the Vocational Industrial Clubs of America, Inc. may claim such member privileges and benefits as may be rendered or offered. Student members shall have no voting rights or privileges in the corporation.

Regulation of Internal Affairs

Authority to regulate the affairs of the corporation shall be vested in the Board of Directors. Positions on the Board of Directors shall be in accordance with the Bylaws of this Corporation.

ARTICLE XI Dissolution and Liquidation

Upon dissolution or final liquidation of the Corporation, the Board of Directors shall, after paying or making provision for the payment of the liabilities of the Corporation, dispose of the remaining assets of the corporation in accordance with its purposes or transfer such assets to the Vocational Industrial Clubs of America, Inc., or any other organization organized and operated exclusively for charitable, scientific or educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
