REGIONAL CONFERENCE

In the South, there were 26 students signed up to take the test. The other competitions are already set up to register on the SkillsUSA National Registration System. In Welding, there are no contestants signed up yet. The deadline has not yet approached. We usually do not get students registered until the deadline is much closer.

With such a low participation rate in the North, Tim Conley asked if we need to cancel regionals for the North and send a certain number of participants straight to the State Conference. Conley additionally asked if after registration numbers are finalized, can we change the limits for the contest. In past years, the number of participants has dropped significantly in Welding.
